Ua galulue fa'atasi nei le LBJ Medical Center i lana tautua i le Ma'i Suka fa'atasi ma Le Matagaluega o le Soifua Maloloina i lana vaega o le Tobacco & Diabetes Campaign ma le Tausala Lalelei o le Pasefika, o le Tausala Lalelei lava lea o Amerika Samoa 2017-2018, Matauaina Gwendolyn Toomatalati, ina ia fa'alauiloa auala, e mafai ai ona e gafataulima le maualuga o lou suka, ina ia le toe a'afia tele lou tagata i lea fa'ama'i ua matua fa'ateleina o tatou tagata e maua ai.

O le taumafaiga fa'apa'aga lenei, ina ia aoga ma so'o ai le atunu'u. Ona o lea ua o'o mai i vaitau e faia ai 'aiga tetele a aiga ta'itasi, faatasi ai fo'i aiga uma ma fiafia fa'atasi, o le a tele fo'i ina fa'alogogata ai i latou ua gasegase i le Ma'i Suka.

I le taumafaiga fa'apa'aga lenei ua atina'e, saunoa le Tausala Lalelei o le Pasefika, "Lea ua faliu mai le LBJ Diabetes Section ma le DOH Tobacco & Diabetes Campaign ina ia so'otau'au mai i lo'u fa'amoemoe e fa'afaigofie ai. Alofa mai talia se fautuaga e avatu ma le agaga maumalo, o'a lava o se ugapepe e malolo lava i le agi a le matagi. Tau ina ia aoga sa'u tu'ualalo, e fa'aumiumi ai le mafutaga fa'ale'aiga a outou matua ua a'afia ma fanau o lo'o talavou

pea ma e mana'omia pea ona fo'i atu i le fale i aso ta'itasi ae fa'afeiloa'i mai i lo outou alofa fa'amatu."

Sa ia fa'ailoa fo'i le afuaga ona ia fa'aaoga lea tautua ma auau o lona fa'amoemoe i lana taumafaiga i le sailiga o le Tausala Lalelei o Amerika Samoa, o le auau fo'i lea e tasi na ia toe fa'aaogaina i lana taumafaiga mo le Tausala Lalelei o le Pasefika.

"O lo'u fa'aaogaina ai o lea manulauti, ia fa'asao mai nisi o fanau talavou mai le o'o atu i lagona o'otia sa ou ui mai ai, ina ua amia le ola o si o'u tama i lea gasegase o le Ma'i Suka. E

tusa ma le 30 tasuaga o soifua si o'u tama ma lea gasegase, ae tusa o le 10 tausaga mulimuli o lona soifua, na avea ai o 'au ma se tasi e tausia fa'apitoa o ia, ma o iina sa ou va'aia ai uiga tiga, o mafatiaga e o'o i le tagata e maua i lenei gasegase. Na i'u ina avea ai lona soifua, ma ua motusia ai le ma'u mafutaga mafana ma lo'u tama pele. O se toe galuega ou te faia ona o le manumanu i nisi o mafutaga faaleaiga e ono motusia fo'i ona o lenei gasegase, lea ua avea ai ma fa'anaunauga, ia tima'ia lo tatou atunu'u, ia 'aua nei e o'o i ai, oe lea e le'i maua i le ma'i suka."

"Afai ua e gasegase ai, e mafai ona e toe alu ese ai. O le aoga lea o tima'iga e fa'ata'ita'i i ai, ma fa'amaoni i ai, ona toe fo'i lea o oe i le tulaga ua te'a

le ma'i suka ma oe. Peita'i afai ua le mafai, ona mafai lea ona e soifua pea ma le ma'i suka, ae faia lau vaega o le a tima'ia ai oe!"

Mo lana fe'au taua e o'o atu i isi atumotu uma o le Pasefika, o le aia faaaogaina fa'amaumauga uma tau togafitiga, ae maise o tima'iga ina ia usita'ia e i latou ua gasegase ai, ina ia mafai ona gataulima e le tagata lava ia lona ma'i suka, e le mai le inumia so'o o fuala'au, ae o le me'a'i paleni ma le fa'amalositino i aso ta'itasi.

"O le a fa'auia nei tima'iga uma i luga o ala feso'ota'i o le Initeneti ma fa'afeso'ota'i atu i le Talavai Ma'i Suka i isi malo uma o le Pasefika, ma e tau-mafai fo'i ina ia asia nei malo i aso fa'ailogaina mo lea gasegase. O se meae ao ina faia, o le tautua fo'i ua fa'ae'e fa'atasi mai ma le tofi lea ua pale ai i lenei tausaga," o se tala lea a Toomatalai.

Sa auai le Fa'atonu Sili o le Matagaluega o le Soifua Maloloina, Motusa Tuileama Nua ma sa ia fa'amalosia ia Matauaina ma le vasega o pa'aga ua amatalia, "O le aso lava lenei e fa'atino uma ai le fuafuaga ua outou fa'ataoto e alu ai le taumafaiga lenei. Aua ne'i toe tu'ua, aua e tatau ona o'o lenei fe'au i le mamalu lautele, a'o le'i mafuli le to'atele o aiga e faia latou fiafia, ma e fa'aofoia ai fo'i le solitulafono i mea tau-mafa o nai sui o lo'o maua i lea

gsegase tumau. Fa'auia ala uma e mafai ona o'o ai i lotofale o aiga ta'itasi lea fe'au taua, ia fa'autagia mai se lapatai a le tatou alo lenei. A tu'u fo'i lea galuega lelei, e toe fa'aoso atu ua pasi mai le taimi aoga lava o lenei."

O le tama'ita'i fo'i o Farrah Lesa, fa'auluulu i ai le Tobacco/Diabetes Campaign a le DOH, sa ia fa'ailoa ai, "O le fa'amoemoe lea na auau i ai le taumafaiga a Matauaina Toomatalai, e matua o gatusa lelei ma le taumafaiga tima'i a le matagaluega o le Soifua Maloloina faapea ma le falema'i tele LBJ, aua o tima'iga nei, a fa'aaoga e se tasi ua fa'afogofa i ai, e tu'umamaina lona a'afiaga i le Ma'i Suka."

"O le tatou atunu'u ua le mama'i i le oge, po'o le tau le lava o taumafa, ua fa'ateleina tausami, ma ua mama'i ai. O nei fo'i tima'iga o le a laluugia lava ma le taumafaiga ina ia fa'ao'o atu ni masini i le vasega o matua matutua ua a'afia, e fuaina ai e le tagata lona suka le maualuga po'o le maulalo o i ai. Ia tautuana, e va'ai lelei lena tulaga, ua avea fo'i ma mea e fa'atutupu mai ai nisi gasegase i le fanau, ae na'o le Tylenol ma le Panadol lea e fa'ataga mai, ma ia lava le inu o le vaiauli.

Groom in rare cross-border wedding is a drug smuggler

SAN DIEGO (AP) — It was a heartwarming scene: A U.S. citizen, forbidden to enter Mexico, wed the love of his life in a brief moment when the gate separating the two countries was opened.

Now a newspaper says the groom is a convicted drug smuggler and border agents are furious that he passed a federal background check and was approved for the "Door of Hope" event last month.

"The agents are upset, feel like they were taken advantage of, feel like they were duped," Joshua Wilson, vice president of the National Border Patrol Council Local 1613, told the San Diego Union-Tribune. "Turns out we provided armed security for a cartel wedding."

On Nov. 18, Brian Houston of San Diego and Evelia Reyes of Mexico signed official Tijuana documents making them husband and wife and then embraced between the doors of a steel border gate that is opened for only an hour or so every year.

It was the first wedding at Border Field State Park during the "Door of Hope" event, which permits people who cannot cross the border to meet for about three minutes each.

"It's a statement that love has no borders," Houston told the Union-Tribune at the time.

Those allowed to take part in the event were supposedly carefully screened.

But it appears the federal background check didn't turn

up the news that Houston is awaiting sentencing after he pleaded guilty to drug smuggling in May in San Diego federal court.

Houston was arrested in February while crossing into the U.S. at the San Ysidro border checkpoint. Prosecutors said 43 pounds of heroin, 47 pounds of methamphetamine and 43 pounds of cocaine were hidden in his car.

Because of his arrest, he is not allowed to enter Mexico.

Because of Houston, the "Door of Hope" event is now under scrutiny.

The nonprofit group Border Angels has organized six such openings since 2013. Executive Director Enrique Morones said the group doesn't vet applicants but provides the Border Patrol with questionnaires filled out by candidates. It leaves background checks to that agency, Morones told the Union-Tribune.

Border Patrol spokesman Takae Michael said Houston was screened through an internal vetting process based on information provided by Morones and a review did not indicate criminal activity.

Morones said he was shocked to learn Houston was a convicted drug smuggler and planned to meet with new San Diego Border Patrol chief Rodney Scott to discuss the case and future events.

"That goes against everything Border Angels stands for," Morones said.

When a beach advisory is issued, it is because water samples indicate that the American Samoa Water Quality Standard for Enterococci has been exceeded. This advisory is in effect until further sampling and laboratory analyses indicate that Enterococci concentrations are within acceptable water quality standards.

The presence of Enterococci in the water indicates contamination by human and/or animal wastes. Swimming in water with high levels of Enterococci may cause stomach problems, skin rashes, and ear, eye, and wound infections. To reduce your risk: avoid swallowing beach water, be sure to rinse or towel off after a swim, and shower once at home. If you are ill, or think you may be ill, AS-EPA advises that you consult a physician before making any water contact in the beaches cited above.

Note: AS-EPA monitors the water quality of 44 recreational beaches on Tutuila, the wharf in Aunu'u, and five beaches on Manu'a. Tutuila advisories are issued weekly on Wednesdays. Aunu'u and Manu'a advisories are issued monthly. Advisories are issued when bacteria concentrations exceed levels determined safe for human exposure. How states are coping with uncertainty of kids' health money

Examples of how states have been reacting to the threat of running out of federal money for the Children's Health Insurance Program. It was unclear how their plans might change with the short-term federal funds Congress approved Thursday.

—Arizona: More than 24,000 children covered. Current funding was expected to run out by the end of December. Could shift children to Medicaid, the health insurance program for the poor, which reimburses states at a lower rate than the children's health program does. Republican Gov. Doug Ducey hinted he could use state funds to continue coverage, perhaps costing \$80 million.

—California: Plans to shift many of the 1.3 million covered children and pregnant women to Medicaid. Officials say this would cost the state hundreds of millions of dollars, could put 32,000 at risk of losing coverage.

—Colorado: Lawmakers approved Democratic Gov. John Hickenlooper's request for \$9.6 million in state funds to finance the program through February. Covers almost 75,000 children and pregnant women.

—Connecticut: State has been notifying thousands of families that the program could run out of money by Jan. 31 unless Congress reauthorizes federal funding. Letters urge parents to enroll their children

Chicago police arrest dozens selling drugs, guns on Facebook

CHICAGO (AP) — Chicago police say dozens of people have been arrested after officers infiltrated an invitation-only Facebook group where they bought guns and drugs.

Superintendent Eddie Johnson said Thursday that police seized 18 guns and \$46,000 worth of drugs, arrested 50 people and secured arrest warrants for 18 more following a nearly yearlong investigation.

Police say the investigation started when an informant told the department's narcotics division about the Facebook group that couldn't be found through the search function.

Johnson criticized Facebook, saying it took investigators months to infiltrate the group because of the company's unwillingness to cooperate.

A Facebook spokesperson told The Associated Press the company is investigating the matter.

Greece: Explosion damages court complex; no injuries

ATHENS, Greece (AP) — A powerful explosion has damaged a court complex in central Athens, causing no injuries.

Police say the blast occurred before dawn Friday, following warning telephone calls to the offices of a daily newspaper and news website.

No group has claimed responsibility for the attack. It

In India, some fear lawmakers are stoking anti-Muslim fervor

NEW DELHI (AP) —

A lawmaker from India's ruling party called the Taj Mahal a blot on Indian culture, saying in October that the famous tourist site had been built by Muslim traitors. In November, another party member offered a bounty for the heads of two people involved in a movie featuring a Muslim sultan. Then, this month, a laborer was hacked to death and set afire while his alleged attacker ranted against Muslims. The series of incidents this fall has reinforced fears that anti-Muslim sentiment has hardened in India in the three years since a Hindu nationalist party led by Prime Minister Narendra Modi swept to power. Some say it has reached a point where Hindu extremists believe they can get away with murder. Others worry that hard-line Hindu leaders want to rewrite the country's rich Muslim history.

The shift in attitudes is happening in a democracy of 1.3 billion people that is often held up as a model for inclusion in the developing world. When former President Barack Obama visited New Delhi earlier this month, he said Muslims were integrated and consider themselves Indian.

Hindus account for 80 percent of the population, compared to Muslims' 14 percent. While there have long been religious tensions, there is a sense the stakes have risen under Modi's Bharatiya Janata Party. The BJP maintained its hold on Modi's home state of Gujarat in election results tallied Monday, although with a reduced majority.

In a tweet this month, Muslim lawmaker Asaduddin Owaisi questioned whether Modi is a leader for all religions or just Hindus. "Remember that you have taken oath on Constitu-

tion," he wrote.

Muslims in India have had to deal with a certain level of discrimination for decades, historian and writer Mukul Kesavan said, noting they often find it difficult to buy or rent homes.

But Kesavan said Modi and his party have given Hindus a sense of permission to lash out against Muslims. He cited cases of mob violence against Muslims who buy or sell cows for slaughter, which is banned in most of the country because Hindus consider cows sacred.

The mobs have gone unpunished in some cases, while the victims or their families have been charged with illegally possessing beef, Kesavan said.

"There have always been two kinds of justice," he said. "But the notion that people now have a license to kill, that is new. This idea of impunity has taken hold so strongly."

The brutality of the laborer's death in the western state of Rajasthan shocked many. TV showed a video of the alleged attacker ranting while the victim lay on the ground behind him. Police have made an arrest.

But in other cases, investigations have dragged on or gone nowhere. Kesavan said police often await advice from the ruling party before acting.

Modi's BJP rejects the notion it is encouraging violence.

At an office in the Constitution Club of India, party spokesman and former lawmaker Bizay Sonkar Shastri said occasional flare-ups between Hindus and Muslims are a natural part of life and began long before his party came to power.

"Our political agenda is only to develop the nation," he said. "We never prefer to do politics on caste, color, religion, or any such sort of things."

He said that in two decades of power in Gujarat, the BJP has built an interconnected system of roads and ensured every village has electricity.

Yet party member Suraj Pal Amu last month offered 100 million rupees (\$1.6 million) to anybody who would behead the lead actress and director of "Padmavati," a still-unreleased Bollywood movie that is rumored to depict a relationship between a Hindu queen and a Muslim ruler. Amu later resigned from his party leadership post in the northern state of Haryana. Police have said they're investigating.

Shastri said he didn't know much about Amu's threat, but that he should be punished according to the law. Shastri went on to say he had heard about the movie's rumored love sequence, which if accurate, would be "very bad" because it would be twisting the Padmavati story. The movie is based on a 16th-century poem in which a queen chooses to kill herself rather than be captured by a sultan.

Second federal judge blocks Trump contraception rules

SAN FRANCISCO (AP) — California faces potentially "dire" public health and financial consequences from new rules by the Trump administration allowing more employers to opt out of providing women with no-cost birth control, a federal judge said Thursday.

U.S. District Judge Haywood Gilliam in Oakland, California, became the second federal judge in the country to block the changes to President Barack Obama's health care law, saying the Trump administration failed to provide the required notice and public comment period before implementing them.

A federal judge in Philadelphia last week cited similar reasons in her nationwide injunction against the rules. That decision came in a lawsuit brought by the state of Pennsylvania.

Gilliam's ruling came in a

separate lawsuit brought by the state of California, which was joined by Delaware, Maryland, New York and Virginia. Gilliam's preliminary injunction will hold while their lawsuit against the rules moves forward.

For a substantial number of women, the new rules "transform contraceptive coverage from a legal entitlement to an essentially gratuitous benefit wholly subject to their employer's discretion," Gilliam, an Obama appointee, wrote.

U.S. Department of Justice spokeswoman Lauren Ehrsam said the DOJ was "evaluating next steps."

The DOJ said in court documents that the rules were about protecting a small group of "sincere religious and moral objectors" from having to violate their beliefs.

"This administration is committed to defending the reli-

gious liberty of all Americans and we look forward to doing so in court," Ehrsam said in her statement.

President Barack Obama's health care law required most companies to cover birth control at no additional cost, though it included exemptions for religious organizations. The new policy would allow more categories of employers, including publicly traded companies, to opt out of providing free contraception to women by claiming religious objections. It would allow any company that is not publicly traded to deny coverage on moral grounds.

California argued that the change could result in millions of women in the state losing free birth control services, leading to unintended pregnancies that would tax the state's health care and other social programs.

A lawyer with the U.S. Department of Justice, Ethan Davis, told Gilliam during a Dec. 12 hearing that it was not clear that any women would lose no-cost contraception coverage.

Washington state and Massachusetts have also sued the Trump administration over the rules.

The U.S. Department of Health and Human Services issued the new policy in October. It marked another step in the Trump administration's rollback of Obama's health care law.

in new health coverage for Feb. 1. Democratic Sen. Chris Murphy said more than 17,000 children could be affected.

—Minnesota: Around 125,000 children covered. State will use more of its own money to cover recipients if federal money halts, said state Human Services Commissioner Emily Piper.

—Oregon: Federal money ran out this month for 120,000 children and 1,700 pregnant women, but coverage continued with added state money. One-third of the children would be shifted to Medicaid. The rest would continue in the children's health program.

—Texas: About 400,000 children covered, expected to have enough money through February. No warning letters sent to families. Christine Mann, spokeswoman of the state health department, says, "We're hopeful that Congress will renew the program soon."

—Washington state: 58,000 beneficiaries. Amy Blondin, spokeswoman of state Health Care Authority, said the program has been functioning with money redistributed from other states. "We're choosing to not send out any notices right now to families."

Raul Castro confirms he will stay Cuba's president to April

HAVANA (AP) — Raul Castro confirmed Thursday that he will continue as Cuba's president into April, two months longer than expected, as parliament extended the political cycle citing delays made necessary by a damaging hurricane.

"I wish to ratify what has already been expressed ... about limiting to two terms of five years the exercise of the principal offices of the nation," Castro told lawmakers, in comments broadcast on state television.

"When the (new) National Assembly is constituted next April 19, my second and last term will have concluded at the head of the state and the government and Cuba will have a new president," he added.

Castro, 86, had previously said he would step down in February at the end of a months-long political cycle in which voters and government officials pick the members of local, provincial and national assemblies and the members of the powerful council of state.

But earlier Thursday, the National Assembly announced that its current term would run through April 19 instead of ending in February because the impact of Hurricane Irma in September had delayed the start of the cycle. The current council of state is also remaining until then.

Many Cubans and outside observers expect Castro to be replaced as president by First Vice President Miguel Diaz Canel, 57, who has promised to continue Castro's policies.

Those include allowing the slow and limited introduction of private enterprise into Cuba's centrally planned economy, while maintaining a single-party system and tight govern-

ment control of virtually all aspects of life on the island.

Vice President Marino Murillo, who is also the government's economy czar, announced new controls and regulations for the non-state sector that come on the heels of earlier restrictions around the middle of this year.

Murillo said there will be no new approvals for the time being for non-agricultural cooperatives, while their maximum and minimum earnings will be limited to avoid the existence of de-facto private businesses.

Some private-sector license categories will be merged, as in the case of manicurists, barbers and hair dressers all falling under a "beauty" designation. Bars currently operating under restaurant licenses will fall now under a separate regulatory category.

Castro is expected to retain his position as head of the Communist Party, which sets the parameters of government policy and overall direction of the country. Castro took over from his older brother Fidel after the revolutionary leader and founder of the current Cuban system fell ill in 2006. The younger Castro began a series of domestic reforms that included the spread of internet and cellphone access, freedom to travel for most Cubans and the ability to buy and sell cars and houses. He also oversaw the re-establishment of diplomatic relations with the United States, a detente that was shaken by the election of Donald Trump as U.S. president last year.

Trump re-imposed restrictions on Americans' ability to travel to Cuba, cutting into a tourism boom that had helped buffer the island's economy against a decline in trade with

PHILADELPHIA (AP) — Parents of a 4-month-old girl say the child was attacked by a raccoon inside their Philadelphia home.

Ashley Rodgers says the attack happened Wednesday night in the family's first-floor apartment.

Rodgers says she had taken her 6-year-old son to the bathroom while the baby was asleep on a bed. She returned to find her daughter on the floor with blood all over her face. Rodgers

says the raccoon had dragged her across the room.

The baby was taken to a hospital, where she received more than 60 stitches and is recovering.

The Animal Care and Control Team of Philadelphia says an officer responded to the home, but couldn't find the raccoon. Officers have since assessed the building and set traps. Officials say no raccoons have been caught yet.
