4	A BILL FOR AN ACT ENTITLED: "AN ACT AMENDING THE
5	REGISTRATIONS OF VEHICLES TO ANNUALLY REQUIRE FEES BASED
6	ON WEIGHT; AMENDING SECTION 22.1002 A.S.C.A."
7	
8	Preamble:
9	WHEREAS, weight was added to registration fees in 1980; and
10	
11	WHEREAS, fees based on weight are levied in over 13 states; and
12	
13	WHEREAS, due to increase use of the roads, inflation, costs to run the
14	government, and the cost to repair roads these fees must be updated; and
15	
16	WHEREAS, heavier motor vehicles place more wear and tear on our roads; and
17	
18	WHEREAS, road repairs and construction come at a huge cost and these fees will
19	help cover a portion of those expenses.
20	
21	BE IT ENACTED BY THE LEGISLATURE OF AMERICAN SAMOA:
22	
23	Section 1. 22.1002 is amended to read:
24	"22.1002 Application for and issuance of license—Fees.
25	(a) Application for a motor vehicle license shall be made to the
26	Commissioner on forms as the Commissioner may prescribe.
27	(b) No motor vehicle license may be issued without:
28	(1) payment of the prescribed motor vehicle license fee;

(2) presentation of a valid inspection certificate issued pursuant to 22.1201 1 et seq.; 2 certification of insurance coverage as required by 22.2001 et seq., 3 provided that such coverage will be effective for the period of the license; 4 (4) issuance of a valid motor vehicle registration. 5 (c) Upon satisfactory compliance with the provisions of this section the 6 Commissioner shall issue 2 decals to the applicant which decals denominate the 7 period for which registration is effective and are to be placed on the license tags. 8 (d) The following vehicle license registration fees are established: 9 motor vehicle, including private vehicles, cargo vehicles, buses, 10 motorcycles, taxis, trailers, tractors and rentals, \$32.00; plus per ton of weight, or 11 fraction thereof, \$12.00; 12 (2) bicycle, \$2.00; 13 (3) renewal for motor vehicle, \$32.00; plus per ton of weight, or fraction 14 thereof, \$12.00; 15 (4) Legal Ownership Certificates and Titles, \$10.00; 16 (5) Transfers, \$10.00; 17 (6) Shipments, \$10.00; 18 (7) Conversions, \$12.00; 19 (8) Duplicate titles, \$10.00; 20 (9) Late penalties, \$9.00. 21 (e) For the purposes of subsection (d), the definitions in 22.0101 apply. 22 (f) The Commissioner shall issue 2 license tags to each applicant: 23 (1) registering a vehicle not registered in the Territory in the preceding 5 24 years; or 25 (2) whose tags have been lost or stolen, upon proof of same. The fee for 26 replacing lost or stolen tags or plates shall be \$22.00. 27 (g) For purposes of this section only, a total of \$7.00 from each fee paid 28 shall be placed in a revenue fund for the Department of Public Safety for law 29

1	enforcement costs and maintenance and supplies for production of driver licenses
2	and vehicle registrations.
3	(h) Half (50%) of tonnage fees collected under A.S.C.A. 22.1002(d)(1)(3)
4	shall be placed in a road maintenance fund to be used for road repair."

6	Sec 2. Effective date.
7	In accordance with Article II, Section 19 of the Revised Constitution of
8	American Samoa and subject to the implementation dates set out above, this bill
9	shall become effective 60 days after the end of the session at which it has been
10	passed.
